Surge protection devices (SPDs) for protection against transient overvoltages Samad Khan, Global Product & Standardization Manager, ABB Furse

Synopsis: Surge protection devices (SPDs) which are used to protect against transient overvoltages (surges) caused by atmospheric origin (lightning) and electrical switching events. The presentation explains what surges are and how they affect modern electrical equipment (as supported by global industry standards) and discusses the key selection considerations of SPDs and how they should integrate within the installation for effective protection.

Samad Khan is a Chartered Engineer graduating from Loughborough University in 1996 with a Master's degree in Electrical and Electronic Engineering. Since then Samad has worked for ABB Furse, a company that specialises in lightning protection for over 120 years. Over this time, Samad has had various roles, from R&D where he was involved with the design and construction of high voltage lightning current generators as well as extensive product design for the protection of electronic systems to global field sales engineering, project management, marketing and specialist technical support. This comprehensive experience led to his present role of Product Manager since 2004 and promoted in 2015 to also cover ABB SPDs globally. In addition to this, Samad is the BSi principle UK expert for Surge Protective Devices (SPDs) since 2001, representing the national committee in European and international meetings for the development of lightning protection standards including the application of SPDs.
