### **Energy Management Systems Assessments**

Energy Management is a concept that has been around for Andrew's entire career. He left school in 1975! Yet in 2017 we still have government schemes being introduced as NEW!!, designed to improve energy management and we still have organisations wondering whether it might be a good idea to do something about their energy use, if only there was something they could do to make a difference.

This presentation aims to explain, in straightforward terms, the various energy management tools that have been deployed by government, how they inter-relate and how to get the best out of them. This will lead into an explanation of the merits of following the guidance set out in the International Standard ISO 50001. Following this presentation you will be left in no doubt about what you can do to make a difference. And it won't cost the earth.

Professor Andrew Geens is Head of CIBSE Certification based in London and is responsible for the operation of personnel and management system certification schemes primarily associated with the energy performance of buildings. Andrew was formerly a Principal Lecturer in the Faculty of Advanced Technology at the University of Glamorgan, has a BEng (Hons) and a PhD in Environmental Engineering, and is a Chartered Engineer and Fellow of the Chartered Institution of Building Services Engineers. His particular interests in indoor air quality, energy performance of buildings and low energy design of buildings complement his current role perfectly. Most recently, Andrew has been conducting ISO 50001 audits as part of the certification process for a number of client organisations

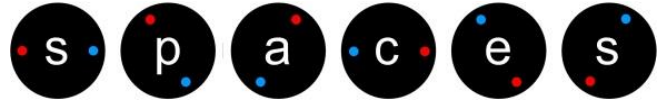
### **The calibration of environmental design and MEP services (update)**
