SPACES membership has become automated, and you will only be able to renew/update your membership via the <u>website</u>.

We are in the process of cleaning the SPACES online database, so if you are Central and Local Government (ie with a '.gov.uk suffix' email address), retired and honorary membership, and those whose membership has not expired, please follow the process <u>here</u> asap. If your email address has changed you will need to reregister <u>here</u>. If your membership has expired, you can renew your membership <u>here</u>. Notes.

- With group membership, you will be able to be able to nominate a group administrator who will manage the membership process and will receive automated reminders for renewal. The group administrator will be able to add the members names and emails addresses and the members will receive an automated email which will allow them to add their region, profession and communication options.

# Heat networks: Building a market framework

The Department for Business, Energy & Industrial Strategy is seeking views on policy options for the development of a regulatory framework for heat networks to protect consumers, support market growth and develop low carbon networks.

In order to achieve net-zero carbon emissions by 2050, nearly all heat in buildings will need to be decarbonised. Heat networks are a crucial aspect of the path towards decarbonising heat.

In this consultation, they are seeking views on policy options for regulating heat networks to protect consumers and ensure fair pricing, while supporting market growth and the development of low-carbon networks.

# Review of the ban on the use of combustible materials in and on the external walls of buildings

The Ministry of Housing, Communities & Local Government is seeking views on the ban of the use of combustible materials in and on external walls of buildings, including building types covered, height threshold, list of exemptions, attachments such as blinds, shutters and awnings, and a proposal to specifically ban the use of metal composite panels in and on the external walls of all buildings.
